# 7. Vertigo Print Motion Vertigo Volume 4 and 5 Print Budget Motion

#### Why should we print volumes four and five?

Since the move to online, Vertigo's readership has declined slowly, which is troubling considering that there needs to be substantial audience engagement for not only the end of this year's team, but the incoming team soon to be elected for 2021. In addition to revamping the website, we believe that the best way to increase engagement overall is to print our two remaining volumes, particularly the election issue, Vol. 4: TRASH, which contains crucial nominee information. As for the final issue of the year, Vol. 5: UNDERGROUND, we believe that this will be a great way to cap off the semester, particularly since semester two has seen a significant return of students to campus.

We believe it's worth there being a magazine for students and staff to enjoy around open buildings, particularly Building 02; Vertigo is part of the university experience, after all, and we believe it's important that we not only honour our commitment to being a print magazine for our contributors, but be enjoyable for anyone on campus—particularly first years, as the print volumes

are usually their first and most important exposure to Vertigo. It helps create a sense of normalcy in a time of uncertainty for the many students who have voiced anxiety about returning to campus. Reading an easily accessible physical volume is not only unifying, but cathartic and distracting. Students especially need that comfort heading into assessment periods. Our print copies also have the unique opportunity to gain even greater exposure than pre-COVID times, given that our university community — which has been almost exclusively consuming content online for the past six months — is craving the rare and incomparable experience of consuming print media. Lately, our favourite magazines and news organisations have shut down, and the majority of our lives has been relegated to the online world. For most of us, that has created an even greater desire to seek the sort of pleasure that comes from

physically and tangibly interacting with content. Our first volume, METAMORPHOSIS, saw the student body begin the year with this tumultuous journey and it only makes sense that our last two volumes, TRASH and UNDERGROUND, see them out at the other end of the tunnel. Reduced engagement also has implications for the overall UTSSA since if students aren't able to pick up the magazine, it creates a less-informed cohort with regards to UTSSA services such as Bluebird Brekkie or hot-button election issues, which carries over detrimentally into 2021.

#### What are the printing parameters?

As Vol. 4: TRASH is the election issue of Vertigo, it contains all of the nominee information for the UTSSA elections in its page number, as opposed to the election insert done in 2019. This bolsters the page count to 150 pages, which is more than the standard 120 Vertigo page count for the year (Vol. 1 was 116 pages, including the front and back covers). The cost of this is reflected in the second part of the quote on the following page. For Vol. 5: UNDERGROUND, the page count is expected to fall around the standard 120 pages.

Marlene, our correspondent at SOS Printing, has provided us with quotes for basic printing

options, including low weight 120 gsm paper (as higher weight paper is more expensive), and for basic perfect binding and no special finishes, all of which goes to making the most affordable

magazine possible. We are hoping that since we have not printed the past three issues of Vertigo that the UTSSA can provide us with a budget to print the final two of the year, and allow Vertigo to re-engage the students of UTS who have not been as engaged during the last three online issues.

#### Higher Cost Per Copy vs. Overall Cost

Based on the quotes provided by SOS printing, it is evident that the printing costs per magazine are higher when printing less copies overall and vice versa. For Vol. 4, printing 1000 copies, 1500 copies, and 2000 copies is \$11.96, \$9.01, and \$7.53 per magazine, respectively. Vol. 5 will cost \$9.95, 7.49, and \$6.25 for 1000, 1500 and 2000 copies respectively. It is more cost effective to print a higher total quantity of magazines; however, the Vertigo print budget overall is at the discretion of the UTSSA.

In summary, more money is saved by printing 1000 copy print runs for the next two issues, however, cost per magazine goes up. While printing 1500 or 2000 copies has a higher overall cost, the cost per issue is reduced and therefore represents better value.

#### 8. NUS Accreditation motion

Every year the UTS Students' Association contributes a fee to the National Union of Students (NUS) which is the peak representative body for students across Australia. The NUS has been crucial for advocating for student rights during the COVID period and it will continue to be as universities face the onslaught of changes to University from the current Government. We've been sent an invoice to pay our affiliation fee of roughly \$275,000. The purpose of this motion is for the Council to decide if we want to apply for a fee waiver so we can pay less fees and decide how much we wish to contribute this year. Keep in mind that last year we contributed \$55,000 to NUS.

#### Motion:

#### That the Students' Association will apply for a fee waiver from NUS to pay \$55,000\* in affiliation fees.

- EVP clarifies that the dollar value in the invoice is never intended to be paid in its entirety
- Secretary suggests 80% of \$55,000 as it reflects the 20% cut that the Students' Association has had

- EVP and Assistant Secretary state that due to being in political factions they somewhat have interest in this motion
- SRC discusses further and agree on \$50,000

  - When contacting them, it should state that we are giving more money proportional to our budget cut as the SRC does not wish to hinder the organisation

# **President's Report**

In the last month the Students' Association has been able to open nominations for the Students' Association 2020 online election successfully which will hopefully continue in the next month and lead to the rest of the process continuing to be run successfully. A lot of the positions are contested which will lead to a stronger association in the future with students being in charge of who they would like to see representing them.

Myself and Erin recently attended a meeting in which we discussed aspects of how students interacting with UTS online material's data is recorded which was a very productive discussion. We were able to raise certain points regarding privacy of students and ensuring that tutors or the University aren't given excessive information about students that they may use to harness against students. We especially discussed the need to ensure that certain cultural aspects of the University would need to change before students might feel comfortable with sharing more of their data with the university. We did also welcome the concept that the use of analytics would be able to aid in improving teaching and learning within the UTS community.

I have also raised concerns brought up by the SRC about the Respect Now Always campaign recently with those in the working group, however, on this front I can not see much of the changes we discussed being implemented. Concerns about the objectifying language and the use of puns inappropriately were somewhat dismissed especially alongside the consideration that the RNA campaign received a prestigious award recently for socially conscious campaign design.

I have also had some discussions with Shirley recently where she explained that she was especially dismayed by some of the more recent government announcements surrounding the tertiary education sector and it seems as if with the proposed changes to the University fee structures and the new first year failing policy, along with lack of additional expected support from the Government to Universities during this period, we have a potential ally with the University executive against these changes and hopefully can in the future determine suitable joint campaigns against the Government changes.

Our time in these positions are quickly ending which is making me very aware that there are many things we can still do as the UTS Association for Students. While we are all very busy at the moment we must keep on track and do our best to support and listen to students over the next few months. I aim to further my commitment to students particularly given the hugely detrimental attacks on education we are seeing.

I have continued with my commitment to sustainability this semester. With the Enviro Collective we are planning ways to encourage students to investigate their current superannuation and how they can (quickly and for no cost) switch their super to ensure their money isn't supporting environmental degradation. I had a meeting with TCorp and numerous UTS staff members last week. Following this, the founder of the Science Sustainability Committee and I cowrite a letter to the Deputy Vice Chancellor of Resources demanding immediate divestment. I am also proud to have been selected as a finalist for the Australasian wide university sustainability awards called the Green Gown awards of which the winner will be chosen in several weeks.

I was fortunate to attend the International Students Welfare Roundtable Meeting to discuss key issues that international students face in Australia. We mainly focused on workplace exploitation and travel concessions. But I was able to bring up further serious issues that I understand to be hugely detrimental to international students. While I am a domestic student, I am proud to have attended as it should not just be international students fighting for international students. We should all be fighting for them.
