6.1.1 Standing Orders

6.1.2 Events Approval Policy

Aidan briefly discusses the document provided to council prior to the meeting. Council has read the provided document. Ellie believes that the policy will threaten the autonomy of collectives holding events, especially snap rallies. Melodie explains the Ethno has an event next week and asks the process of approval for this event. Aidan explains the 3 possible bodies that can approve an event. Will asks why we are passing the motion if this is already standard practise. Aidan explains that it is the current standard practise, it just is not in writing yet. Clodagh asks who the first authority is to ask for event approval. Aidan explains that the process begins with the Collective OB, then President, Exec or Council. Ellie questions whether its appropriate for the President to have this power, not just for this year, but for coming years. Mehmet explains that he originally wrote this but not with the extreme power of the president in mind, more to streamline the process of organising and approving an event.

6.1.3 Communication & Meetings Policy

Camille and Sabrine have drafted a policy intended to increase productivity during work hours and increase positive mental health and protect personal time.

Going forward, all UTS Students' Association ('SA') meetings should be scheduled for weekdays and start no later than 7:30pm and finish no later than 9:00pm. These guidelines allow SA members to decompress and allow time for a healthy sleep. For inevitably busier times, meeting times can be extended with a 2/3 majority of attendees, however we should strive to avoid this as much as possible to promote a healthy work/life balance in the SA. Long and late meetings should not be the norm.

Emails should be the standard mode of contact between members of the SA, not only because it doesn't blur the line between professional and personal modes of contact, and not just because it allows people to take their time with reading and replying, but also to retain legacy information for the people who will take over our roles next year. Although we will still retain and utilize our group chats appropriately, SA correspondence should first and foremost be sent via our student/SA email accounts. Association members should also avoid contacting other members on non-meeting days outside of the regular workday i.e., 9am-5pm through non-email modes of communication. Our social media should remain social, and not professional.

That the UTS Students' Association ('SA') adopts the following Communication and Meetings Policy:

- 1) All meetings shall be scheduled on weekdays, with start times no later than 7:30 pm and end times no later than 9 pm.
- 2) A motion to extend a meeting past 9 pm requires a two-thirds majority agreement.
- 3) That all SA correspondence be delivered via email, and that SA related contact on non-meeting days should not be made via any social media site outside of the regular working hours.

6.1.4 Vertigo Printing

Aidan happy with the response from the recent Vertigo publication. Aidan has submitted an alternative motion for \$9000 to print 1 further issue.

Rachel from Vertigo believes both should be printed. Stands have been empty demonstrating an interest in the printed issues. Points out that this is a small amount to publish in contrast to previous years. Mariah is happy with current issue, points out that this is the most expensive one ever printed and believes the compromise is a good idea. Suggests printing more of the same issue could be beneficial as its cheaper than printing 2 separate issues. Council believes foot traffic on O'day is

responsible for the increased interest and worries that when things calm down, there will not be as many students picking it up. Rachel asks if the next issue is well received, will the council potentially approve further budget for another issue. Aidan says we should approve initial compromise and reevaluate after this one is printed.

Motion to approve Aidan's revised budget of \$9000 for one further printed issue of Vertigo.

6.1.5 Myanmar Motion -Ethno

Melodie speaks to the motion provided. Observer May Tun, a Burmese student has been working with Melodie on writing this motion.

Motion for the SA to stand in solidarity with Burmese students fighting in Myanmar and with Burmese students. May Tun hopes that more students will become aware of the situation facing Burmese students in Myanmar and in Australia.

Clodagh explains that the nature of 2nd hand items can be sold very quickly on Facebook Marketplace, Gumtree and Op Shops. Aidan explains that if the Queer Collective agree on items, Queer Collective can purchase and make a reimbursement motion to submit to Exec.
