Olivia, speaks to the importance of Queer Vertigo and keeping it autonomous from Vertigo as a soley queer publication.

Rhiannon, speaks to a common goal and the importance of the magazine after the delay of the normal 2 year cycle of publication due to Covid.

Gracie, there are so many voices within the collective that are not given a platform and the pandemic disproportionately affected marginalised students and it's particularly important as by re-activating campus, UTS should take more of a stance as a more of a queer friendly university.

Elijah, supports the creation of Vertigo because it gives voices to intersectional people and a lot of Queer work remains surface level or performative e.g wear it purple day

Cal, there has not been a Queer Vertigo for a long time and especially with a lot of the terrible things to community has had to deal with it comes at a good time

Suzy, is it separate to Vertigo?

Rhiannon, yes we may reach out to Vertigo for advice however the current Vertigo team won't have anything to do with the magazine.

Aidan, Queer Vertigo can be extremely powerful and impactful and it's a great opportunity to endorse a Queer Vertigo in principle. However, there will have to be a business case made in terms cost and quotes etc.. Especially since Vertigo has been a pain point for president for many years. If you can reach out to Vertigo and have an autonomous Queer chapter that may be a possibility for cost cutting.

Rhiannon, yes we would have to ask Vertigo byt might be a big ask if they already have all their editions planned out

Olive, we recognise that the Queer experience is not universal and that that budgeting is also a big concern and I've been in contact with printing services. In terms of taking over the Vertigo magazine, we would not want to but in to their already laid out plans and doing it online would be a disservice to the magazine as since 2005 it's always been a hard copy

Melodie, what about a zine? That would be very queer.

Olivia, quite small scale for what should be a large-scale magazine

Melissa, says it gives heaps of people opportunity to publish their work and making it super accessible to those who want to contribute and consume.

Harry, has an issue with the Vertigo editorial team not being brought to the table as they are directly elected and the team should at least have room to input as it undermines the whole point of electing the whole team. If you can use the Vertigo name but print a completely disconnected magazine it that may be an issue

Olivia, I understand where you are coming from so at the end of the day the whole Vertigo team is not Queer. So even though they get elected we are also elected by our collective.

Anna, just to clarify it's called Queer Vertigo but is not connected to the magazine?

Sabrine, what about the queer members of Vertigo allowing to be let in on the process?

Gracie, Vertigo can help coordination and certain logistical things but when it comes to creative judgment the people who are running it from the collective side of things, we would rather they avoid stepping on toes but it's just about having that conversation. A lot of people don't like publicising that they are queer so I don't see a problem with certain members of the team being there especially because the democratic process is so different for queer because we want to vote to remain anonymous.

Olivia, no qualms about any queer student getting involved from Vertigo just want it to remain sperate to the magazine

Eshna, the big issue coming up is that it is called queer 'Vertigo'. So, since it's so attached to Vertigo then can we use a different name and that will separate it from Vertigo and alleviate that stress about democracy and about the Vertigo being involved. Also, Shirley can't say that we are spending too much on Vertigo because it's separate.
